**General Summary**

Perform general repair of and maintain Airport Property, including mowing and other maintenance tasks.

**General Duties**

1. Attach and operate various equipment and mowers to tractors for maintenance of airport property.
2. Attach and operate equipment to broom runways, taxiways and apron areas of the airport.
3. Operate and attach snow removal equipment.
4. Ability to operate power equipment such as lawn mowers, chain saws, weed eaters, power saws, etc.
5. Perform minor maintenance tasks such as carpentry, roof repair, plumbing, painting and electrical as needed.
6. Responsible for the daily inspection and maintenance of equipment. Performs routine maintenance on equipment, i.e. replace parts, filters, changer oil, etc. to maintain equipment in good operating condition.
7. Operate a variety of maintenance equipment including but not limited to pickup trucks, dump truck, tractors, sprayers, mowers, skid steer, ditch bank, and loader attachments.
8. Ability to perform minor electrical work (if licensed).
9. Repair roadways using a cold mix asphalt.
10. Subject to 24-hour emergency call in.
11. Must be available every third weekend for fuel system review (2 hours per day).
12. Ability to complete fuel delivery inspection, assist in aircraft refueling, fuel safety regulations, and fuel properties.
13. Understand emergency action plan, airport layout plan, and traffic patterns with proper training.
14. Performs other task as assigned by the maintenance foreman or Airport Manager.

**Physical Effort Work Environment**

Performs duties involving physical exertion such as standing/bending for long periods of time, depth perception, hearing, lifting/carrying objects weighing up to 50 pounds on a regular basis and more than 50 pounds occasionally, pushing/pulling objects, crouching/kneeling, reaching, bending and handling/grasping objects. Most work will be performed outdoors.

**Personal Work Relations**

Employees maintain frequent contact with co-workers and the public for the purpose of exchanging information. Employees are frequently assigned work tasks and have little direct supervision in the performance for the task.

**Working Conditions**

Employee occasionally works extended hours and on weekends or evening and nights for special events and snow removal. Position rarely requires out of town travel. Employee will be working outdoors in temperatures in excess of 100 degrees and below freezing through out the year.

**Employment Qualifications**

Education – High School Diploma or GED required. Prior experience operating maintenance equipment a plus.
