- F. New Business
  - A. The Mayor presented a request for the Farmer's Market lot for:
    - Spudbank – March 6, 13, 20, 27 from 11 am to 2 pm
    - Auntie Anne's March 19, 11am to 6 pm.
    - Chik -Fil-A Columbus, March 3, 10, 17, 21, 24, 28, 31 from 11 am to 1 pm.
    - On a motion by Mr. Lucas, seconded by the Mayor, the requests were approved.
  - C. Dave Eggers (K of C) presented the annual request for Fruhlingsfest, May 16<sup>th</sup> and 17<sup>th</sup> in the B&O parking lot. Requesting closure of the lot on 5/15 at 4 pm, and the use of picnic tables, trash cans, and barricades. On a motion by Mr. Lucas, seconded by the Mayor, the request was approved.
  - D. Whitney Koelling presented a contract for ARA to administer the OOR grant the City received (\$350k plus \$50K city match). On a motion by Mr. Lucas, seconded by the Mayor, the contract was approved for signature.

I. City Engineer Bernie Hauersperger shared the following:

- Bernie presented an update on the GAI Consultants contract amendment regarding South O'Brien Road reconstruction. Fee was negotiated down to \$25,240 from \$28,000. On a motion by Mr. Lucas, seconded by the Mayor, and amendment was approved.
- Bernie also presented a quote for the 12" main relocation at 2<sup>nd</sup> and Community for \$78,670. This was not part of the original 2<sup>nd</sup> St. project. On a motion by the Mayor, seconded by Mr. Lucas, the quote was approved.
