These are the Minutes from the B.Z.A. Meeting that was held on November 28,2023 at Seymour City Hall Council Chambers and GOTOMEETING.

The structure is still up and the BZA members asked Chris Attorney about it, she told them she had sent Ms. Anderson a letter with her options of tearing it down or being fined. No response has been given, so the BZA decided to give her till the end of 2023 for results and another letter sent to her. They will revisit it in January at the next BZA Meeting.
